B. Introduction to IQAC:

We are affiliated to Visvesvaraya Technological University (VTU and approved by the All India Council for Technical Education (AICTE). MVJCE has on-campus learning centres in collaboration with companies such as National Instruments, Infosys and Texas Instruments. Aeronautical Engineering, Chemical Engineering, Computer Science Engineering, Electronics & Communication Engineering, Electrical & Electronics, Information Science Engineering and Mechanical Engineering are accredited by the National Board of Accreditation. The Institution is accredited by NAAC with B++ grade (3.00/4 scale)
